**RE: Title I, Section 101 Financial Report and Narrative**

Dear Election Assistance Commission:

As requested by the EAC, the below information is a detailed list of expenditures made by Tennessee with the funds provided under Title I, Section 101 between the months of April 23, 2003 and December 31, 2003. Included in this packet is the Standard 269 financial report for Sections 101.

**TITLE I Section 101**

1. Computerized Statewide Voter Registration List

According to Title I, Section 101(b) (A) funds shall be used to comply with Title III. Title III, Section 303 requires each state to have a statewide voter registration list.

In order to make our voter registration list HAVA compliant, Tennessee hired a System Administrator to assist in the implementation of the necessary changes and upgrades to the system. In order to implement the necessary changes, the System Administrator will need to travel to the 95 counties throughout the state.

Therefore, Tennessee spent \$26,469.22 in this category which included salary, benefits, retirement and travel expenses. An additional \$2142.14 was spent on office supplies which included a personal computer. The total amount spent towards this category was \$28,611.36.

A \$1,000.00 NASS HAVA Implementation fee was paid during this period of time which covered training sessions, the cost of conference calls and meetings between State and Federal officials.
